**4. Entries and accreditations**

**Entries by names of fencers, teams and all officials (including coaches)** must be made on the FIE website [www.fie.org](http://www.fie.org), by the deadlines indicated in article o.53 of the Competition Rules: 15 days at the latest (midnight Lausanne time) before the first competition in the championships.

**Out-of-quota** entries of Presidents and General Secretaries of national federations, members of FIE Commissions and Councils, Presidents of FIE confederations and Members of Honour of the FIE, must be made directly on [www.fie.org](http://www.fie.org) by the national federations.

A fine will be imposed for any entry/accreditation of an athlete, a team or an official after the deadline.

**5. Photos**

## 5. Break time in the event of injury or cramp

Further to the tests conducted at the Junior and Cadet World Championships in Bourges (FRA) and Plovdiv (BUL), and the decision of the 2016 Congress, additional tests will be conducted at the Senior World Championships 2017 in Leipzig (GER). A final decision will be made at the Congress 2017.

### t.33. 1.

For an ***injury or cramp*** which occurs in the course of a bout and which is properly attested by the delegate of the FIE Medical Commission or by the doctor on duty, the Referee will allow a break in the fight lasting no longer than 5 ~~40~~ minutes. This break should be timed from the point when the doctor gave his opinion and be strictly reserved for the treatment of the ***injury or cramp*** which brought it about. If the doctor considers, before or at the end of the 5 ~~40~~ minute break, that the fencer is incapable of continuing the fight, he will decide that the fencer should retire (individual events) and/or be replaced, if possible (team events) (cf. o.44.11.a/b).

## 6. Payments due, reminder

In accordance with article 10.2.2 of the FIE Statutes, a federation which is not up-to-date with its financial obligations towards the FIE by midday of the day before a World Championships begins (cadet, junior, senior and veteran) cannot take part in these World Championships, except in the case of a justified exception made by the Executive Committee.
