### \*SFSC 2019 - Payment and cancelation policy (part of the terms and conditions)

- See prise list for the camp fee of SFSC19 below
- **Registration:** we ask every participant (fencer, coaches, leaders or parents) to register him/herself latest until the **30**<sup>st</sup> **April 2019**, by sending us this filled registration form and paying the camp fee (see process below). We will confirm your registration once the payment is received.
- Payment plan (optional): Fencers can choose the option to pay the camp fee in 2 equal parts (50%+50% of the selected price) with the following payment plan: First half of the fee is due with registration (via this form), latest until the **30st April 2019**. The other half of the camp fee is due by the **31**<sup>st</sup> of May 2019, without further information or reminder from us. In case of late payment of any of the two equal parts, your registration will not be binding and your place in the camp can be resigned to another fencer.
- **Cancelation policy:** In case of cancelation before 31<sup>st</sup> of May 2019, fencers are entitled to the refund of thirty (30) percent of the already paid camp fee, in case the fencer has paid the total fee in one amount. No refund is possible at all if you paid 50% of the camp fee before the 30st April 2019. From the 1<sup>st</sup> of June 2019, the registration is binding, and no refund is possible.

#### **TERMS and CONDITIONS**

The customer, (You the Fencer as 'Participant' or Parent/Guardian) and the organizer (En Garde Fäktförening, Solna, 'EGF') are hereby enters the following agreement of terms and conditions to book a place in Scandinavian Fencing Summer Camp 2019 ('SFSC19').

**Billing and Cancellation policy:** EGF sends the invoice via email. In case of cancellation of already paid fee, see rules for cancellation policy above (\*). Reminder is sent on all unpaid and due invoices once. Withdrawal of 14 days does not apply in case of booking of a sport event that is provided for a specified period in time.

**Communication:** EGF communicates in most cases through e-mail provided in this registration form, and the social media (Facebook, Instagram) sites of SFSC19. It is every participants or legal guardian's responsibility that the e-mail address provided here can receive e-mail from EGF, and that they are responsible for keeping themselves informed about the messages sent out either by e-mail or social media.

**Personal information:** Once Participant has submitted a registration to EGF, Participant's personal information is saved and used only in communication regarding information of the camp in 2019 and news regarding our upcoming camps. EGF can even use Participant's contact details to send follow up questions on SFSC19, for example regarding the staff or organisation. Personal information is used only by those at EGF who participate in the organisation of this camp. In cases of third party use of personal information (eventually any sponsor or supplier of SFSC19) EGF shall establishe special so-called personal data assistance agreements with its partners, which means that the 3<sup>rd</sup> party has the obligation to delete the personal data as so on as it is used and that 3<sup>rd</sup> party may not use Participant's personal information for anything other than EGF specified with them. EGF don't use personal information on will be deleted right after the end of the camp. Participant has the right to request access to Participants personal data by requesting an extract. Participant can also request that EGF correct, supplement, delete or limit the processing of personal data so long it does not interfere with EGF's ability to fulfil our agreement with Participant. Participant can at any time get a copy of the personal information. If Participant requests extracts very often, EGF can charge a reasonable fee for administrative costs.

Legal base for personal information management: According to the Data Protection Act, a legal base for processing each individual personal data is required. Virtually all personal data EGF registers and processes EGF does to be able to fulfil the agreement with Participants. Legal base is this agreement. In cases where EGF sends information via e-mail even after Participant has participated the camp, EGF use this agreement as legal base. EGF assumes that Participant is interested in taking part in offers that are related to EGF events. In some cases, EGF market itself digitally even if Participant has not been a customer, and in this case EGF does so only when EGF has seen that Participant has shown interest in such information.

**Insurance:** Swedish participants are covered by insurance from Riksidrottsförbundet via their club. Non-Swedish participants should be covered by their own insurance policy (private, home club or national federation).

**Waiver of Liability:** This waiver of liability/permission form must be signed by the Participant prior to the start of any classes, practice sessions, programs, competitions or club activities with the SFSC or held on the premises of the SFSC19. If the Participant is a minor (under 18 years of age before the first day of SFSC19), the form must be filled out by the parent or guardian of the participant. No Participant or club member will be allowed to participate without this completed form.

Upon entering events arranged by EGF, SFSC19 or taking place at EGF or SFSC19, Participant agrees to follow the rules of EGF or SFSC19. Participant understands and appreciates that the participation in a sport carries a risk of serious injury, including permanent paralysis or death. Participant voluntarily and knowingly recognize, accept, and assume this risk and release EGF and SFSC19, its coaches, its members, and its sponsors (including, but not limited to SFSC19) from any and all liability stemming from Participant's participation or related activities.

**Use of footage recorder during the camp:** By signing this agreement, hereby Participant grants SFSC 2019 and EGF permission to publish interviews, photograph(s) or video footage recorded during the camp of Participant in EGF media channels used by SFSC19 now or later (on Instagram, Facebook, website, printed marketing material). Participant will make no monetary or other claim against SFSC19 or EGF for the use of the interview and/or the photograph(s)/video footage.
