The Modern pentathlon Federation of the Republic of Kyrgyzstan have the pleasure to invite a delegation of your country to participate in the International competition **“Open Jury Horishko Memorial”(men-women)** which will take place in **Bishkek city** from **26 September – 29 September 2019**, according to the following program:

September 25 Arrival of Delegations

September 26 Arrival of Delegations ,Technical Meeting

September 27 Swimming , Fencing , Riding (Women)

September 28 Riding(Men) , Laser Run

September 29 Mixed-Relay competition

September 30 Departure of Delegations

COMPETITION FORMAT

- the maximum number of athletes per gender and nation for each event is four (4) athletes, according to UIPM competition rules for all Olympic Qualification events (R 1.12.8)
- women's and men's qualification will be held
- if there are free places, the host nation may compete with 6 athletes per gender if the event is not a direct Olympic Qualification event. (R 1.12.8)
- **The competition will count towards Olympic Pentathlon World Ranking (OPWR) list – if fulfilling the criteria according to UIPM Competition Rules and Regulations (R 1.19.2)**

RULES

The competition will be carried out according to the UIPM Rules.

Swimming: 25m indoor swimming pool / 5 lanes

Fencing: 8 pistes

Running: Cross covering (a ground)

Shooting: Laser Run:18 laser targets, CO2,ground . According to the UIPM rules.

Athletes Licenses/ Riding Ability

Athletes are only allowed to participate in UIPM sanctioned events if they are in possession of a valid Athletes License. Registration is not possible without a License Number. If an athlete does not have a license, they will not be allowed to take part in the competition. You are reminded of Rule 1.12.1 ii): Pentathletes without riding ability listed in the database and without a letter/ certificate from their NF confirming their ability to ride may not compete in the Final. Such Letter/ certificate must be uploaded on UIPM portal before registration. In addition, the athlete must show sufficient riding ability already in the warmup, otherwise he will not be allowed to compete in the riding phase.

All athletes are kindly requested to wear their official national uniform at the competition. Please also bring a track of your national anthem and a national colour.


