INVITATION – CADET & JUNIOR EUROPEAN CHAMPIONSHIPS

Information Letter no. 02-2022

Dear Member Federation,

with this letter I am sending you official invitation for Cadet and Junior European Championships which will be held in Novi Sad in date 26.02 – 07.03.2022.

Please forward this invitation to persons who will be in charge during the Championship.

We would like to pay your special attention for below issues:

- a) The inscriptions for cadets have to be done exclusively at the EFC Service portal by the national federation, and all fencers must be in possession of the EFC license for the season 2021 – 2022.
- b) The inscriptions for juniors are to be made at both, the EFC Service portal (NO EFC license is required, but that step is required for the uploading of the Annex B – Acknowledgement of liability), and at the FIE website (the FIE license for the season 2021 – 2022 is required).
- c) The described procedure is needed to be followed because cadets' rankings are stored in the EFC database, whilst juniors' rankings are present only in the FIE database. The EFC Cadets Rankings will be used for the seeding of cadets in the individual competitions, whilst for teams seeding the results from individual competitions will be used. Regarding the initial seeding of juniors, the FIE individual and team rankings will be used.

- d) Respecting the complicated Covid situation there is one new step to carry out during the inscription process: at the entry of every fencer you have to upload the signed and scanned Annex B - Acknowledgement of the liability the way you chose the fencer as always (see the [print screen 1](#)), then you have to click on *Show a report of my nation's inscriptions* to see the new screen (see the [print screen 2](#)) where on the right side the menu "Waiver and Upload" appears. Only after uploading the document, the fencer will be registered for the competition because that operation is mandatory.
